


1 WHEREAS, the most recent data indicate that a Class Member Data Form has been returned by
2 the personal representative or successor-in-interest for approximately 61% of deceased class members;
3 and

4 WHEREAS, the parties agree that, in light of the Covid-19 pandemic and difficulties locating the
5 representatives of certain deceased class members, it is in the best interest of the class to extend the
6 deadline in Settlement Agreement, at ¶ V- A-12(v), by one year, thus allowing the Settlement
7 Administrator until April 22, 2022, to identify or locate the personal representative or successor-in-
8 interest of deceased class members; and

9 WHEREAS, the time period provided for in the Settlement Agreement, p. 18, ¶ V- A-12(v), should
10 be extended for an additional year, to April 10, 2022;

11 IT IS STIPULATED that the time period to identify or locate a deceased Class Member's
12 personal representative or successor-in-interest pursuant to the Settlement Agreement, p. 18,
13 ¶ V- A-12(v), is extended until April 10, 2022.


